

Terms & Conditions – RUBIS Card Exclusive Viewing Area Promotion – Jersey International Motoring Festival 2026

7. Entry to the Exclusive Viewing Area is subject to capacity limits and will be available on a first come, first served basis. Access cannot be guaranteed during periods of high demand.
8. The Exclusive Viewing Area is intended to provide enhanced viewing opportunities of the Active Arena entertainment, including live vehicle demonstrations, stunt displays, burnouts, and motorcycle performances.
9. Access to the Exclusive Viewing Area is non-transferable and may not be exchanged for cash, alternative benefits, or any other substitute.
10. FSCI reserves the right to refuse entry or remove any individual from the Exclusive Viewing Area where behaviour is deemed unsafe, inappropriate, abusive, intoxicated, or in breach of event rules or instructions from event staff.

FSCI accepts no responsibility for any interruption, cancellation, postponement, restricted access, or changes to the Jersey International Motoring Festival 2026 event schedule caused by circumstances outside its reasonable control, including but not limited to weather, safety concerns, or operational requirements.
